Dear Sir/Madam.

As you are aware the National Legal Services Authority (Free and Competent Legal Services) Regulations, 2010 were amended vide notification dated 22/10/2018 published in the Gazette of India on 25/10/2018.

- 2. After the aforesaid amendment, the composition of the Monitoring and Mentoring Committee at the Taluk Legal Services Committee provided under Regulation 10(5) is as under:
 - "(5) The Monitoring and Mentoring Committee at the Taluk Legal Services Committee shall consist of,
 - (i) Chairman of the Taluk Legal Services Committee;
 - (ii) one retired judicial officer;
 - (iii) one advocate of 10 years standing or more."
- 3. It has been observed that some of the TLSCs are finding it difficult to set up the Monitoring and Mentoring Committee with the above composition. Hence, Hon'ble Executive Chairman has been pleased to allow the TLSCs to set up such Committees with the following composition:
 - "(i) Chairman of the Taluk Legal Services Committee;
 - (ii) one retired judicial officer; or
 - (iii) one advocate of 10 years standing or more."
- 4. You are, therefore, requested to advise the each of the TLSCs to constitute the Monitoring and Mentoring Committee immediately with the composition as mentioned in para 3 above.
