2. The lawyers mentioned above are designated as Retainers for the period mentioned against their names or until further order whichever is earlier. Retainers devote their time exclusively for legal aid work and shall be always available to deal with legal aid cases (such as drafting notices, sending

replies to lawyers, notices and drafting applications/petitions etc.) and to man the Consultation Office in their respective Legal Services Institutions.

3. In the case of court based legal services, the above Retainer lawyer(s) shall after consideration of the application, forward the same to the Committee for further action. In case of other types of legal services, the lawyers in the office may himself/herself provide such legal services.

4. The Retainer lawyer(s) shall not ask for or receive any fee, remuneration or any valuable consideration in any manner, from the person to whom he/she has rendered legal services under the said scheme.

5. The aforesaid Retainer lawyer(s) shall assist and advise the applicant to give legal aid.


6. The Office shall be at liberty for withdrawing any case from the Retainer during any stage of the proceedings.

7. The Retainer lawyer(s) should maintain a Diary of the activities as per proforma provided by the NALSA.

8. The honorarium payable to Retainer Lawyer(s) shall be Rs.25,000/- (Rupees Twenty five thousand only) per month.

9. In case, any empanelled Panel Lawyers who does not want to be designated as Retainer Lawyer then he/she may informed to the undersign within 15 days from the date of issuance of this notice about the same.
